



#### Hari Prasad Babu C, Member



# Secretary's Annual Report



On behalf of the Board of Governors, I am presenting this 34th Annual Report of the Society for the financial year 2022–23.

We could have had a better year for the Society's finances. This is the second year in a row that the revenues of the Society have decreased. The primary reason is that some of the anticipated assignments in the important project vertical of the Society, Sanitation and Waste Management, which have been the focal point of our efforts in the past few years, have yet to materialize. Regarding another rural empowerment project, we incurred significant expenditures but did not generate revenue during the year. Nevertheless, hope is forever, and we remain confident that our revised strategies will result in improved financial sustainability in the coming years.

Despite the challenging conditions of the past year, with financial constraints and stress, we are able to keep going and develop ambitious strategies to help make a difference in rural areas.

Let's examine what we did and where we stood during this challenging year.

- Financials: For the financial year 2022–23, the total revenue of the Society was ₹ 2,7 million, while expenditure was ₹ 6,0 million, comprising ₹ 3,4 million for Projects and Programs. Due to reduced revenues, certain initiatives had to be scaled down, and others had to be modified. All in all, the Society's operations led to a financial loss of ₹ 3,3 million.
- Our Work: Over the year, our activities included monitoring development programs, building microenterprise capacity, and developing a model for micro and small entrepreneurship empowerment in rural areas. We've worked in five states: Andhra Pradesh, Karnataka, Kerala, Odisha, and Telangana.
- Evaluations and Studies: Over the past year, we have monitored the Ministry of Rural Development, Government of India's flagship developmental programs to improve rural life and livelihoods in 13 districts spread across 4 states, covering 144 villages in 43 blocks, as an Institutional National Level Monitoring Agency. These programs include MGNREGS, PMAY-G, NSAP, DAY-NRLM, PMGSY, SAGY, PMKSY, DILRMP, DDU-GKY, RSETI, and SVAMITVA.

- Rural Entrepreneurship Development: As a District Resource Agency for Andhra Pradesh Food Processing Society, for a brief period during the year, we had the privilege to guide more than 200 micro-entrepreneurs in remote areas spread across two districts in Andhra Pradesh under 'Pradhan Mantri Formalization of Micro Food Processing Enterprises' [PMFME] scheme, a flagship initiative of the Ministry of Food Processing Industries, Government of India, aimed to promote the formalization of the sector. We needed more resources to continue this prestigious initiative. We hope to return to PMFME soon, adequately equipped.
- In addition, we are reimagining our ongoing work on rural skill support and development as a scalable platform for small and micro-entrepreneurship to drive sustainable socio-economic development in rural and non-urban segments of the country, which we look forward to sharing soon.
- · Here is something about the ongoing works:
- CSR initiatives: We had the honor of partnering with NTPC Limited, India's largest energy conglomerate, on one of their CSR initiatives this year. This project's scope is to install solar streetlights in a remote village in Peddapalli District, Telangana. Located near NTPC's thermal power plant in Ramagundam, this project was entrusted to us in February 2023 and is ongoing. We are proud to be able to help light up a rural village inhabited by marginal communities mostly.
- Clean India: Since its inception, REEDS has been actively involved in several interventions related to the Swachh Bharat Mission, one of India's most critical developmental missions. We are proud to have carried out the highest number of verification missions for ODF-declared villages (11,000+) across the country and are continuing to do so. We're excited to get another chance this year to participate in SBM Phase-II, where we'll be assessing 419 ODF Plus villages in 10 districts in Andhra Pradesh. This project was entrusted to REEDS in February 2023. The project is currently underway.
- Educational Support: During the year, we continued extending a small financial contribution to a girl child to enable her to continue her educational journey. We are delighted to note that she is succeeding in her studies.
- Registrations & Certifications:
- FCRA Registration: Our Registration under the Foreign Contribution Regulation Act, 2010, has been renewed by the Ministry of Home Affairs, Government of India, in August 2022 for 5 years. Thus, REEDS can continue to receive foreign contributions for its social and economic activities.

- ISO Certification: REEDS is now an ISO 9001:2015-certified organization. The Bureau of Indian Standards granted a license for Quality Management Systems (QMS) certification to REEDS in November 2022, valid for three years. It's a testament to our robust processes within our programs that meet the established quality assurance standards.
- Board of Governors: REEDS is governed by a board elected by its members for a term of office of two years. The tenure of the current Board of Governors will end at the 2023–24 Annual General Body Meeting. We sincerely appreciate the Board who have dedicated their time to leading REEDS and making it a sustainable organization.
- Advisory Council: We are always honored to have an esteemed Advisory Board and an Expert Group for the Rural Empowerment Initiative. To add wings to our grand ambition to be a change-maker at scale, we have broadened our Advisory Board with a few young empowerment advocates and seasoned career professionals: Harshita Sannapureddy, Suma Niveditha Karasala, and Vijay Reddy. Their collective and unique skills, knowledge, and insights into the organization's work inspire us to advance our mission and vision.
- Way Forward: The rapidly changing operational environment, especially during and after the COVID-19 pandemic, necessitates re-examining our resources, working practices, and delivery modalities. We need to re-position ourselves to respond to the changing transformative economic, environmental, and social conditions in rural life. We have started re-strategizing our approach to allow us to be a multiplier of change at scale. We plan to be on track by the end of this financial year.
- Acknowledgments: Thank you, Team REEDS, for your hard work throughout this challenging year. We
  extend our sincerest gratitude to our donors, program/project partner agencies, state and district
  governments, bankers, implementing and collaborative partners, and members of the Society, advisory
  council, expert group, and Board of Governors for continuing to support us in our mission.
